The cemetery committee report was given by David Hollingsworth. Laura Sue Smith indicated that she met the Hopewell Middle School students at Archeology Day and discussed their Union Hill Cemetery project.

The marker committee report was given by Chris Dyer. A community marker is being prepared for Jarrell. A black church in Thrall is interested in a marker. The City of Round Rock has commissioned an application for a marker for Downtown Round Rock. March 10<sup>th</sup> 2009 is the planned dedication for the Granite spill marker. An application for the Granger High School Gym has been turned in.

The Taylor Heritage & Conservation Society will selling 2009 calendars for \$10 to support their annual scholarship fund. Suzanne Huser, the artist, will be signing calendars from 1-5pm on November 20<sup>th</sup> at Frills in Taylor
